### 4. First-aid Measures

#### Description of first-aid measures.

##### **General advice.**

Move victim to a safe isolated area. When symptoms persist or in all cases of doubt seek medical advice.

## 5. Fire-fighting Measures

**Extinguishing media.****Suitable extinguishing media.**

Use: Dry powder. Alcohol-resistant foam. Carbon dioxide (CO<sub>2</sub>). Water may be used to cool and prevent the rupture of containers that are exposed to the heat from a fire.

**Extinguishing media which shall not be used for safety reasons.**

**Special hazards arising from the substance or mixture.**

Vapors may travel to areas away from work site before igniting/flashing back to vapor source. Thermal decomposition can lead to release of irritating and toxic gases and vapors. ## 6. Accidental Release Measures

**Personal precautions, protective equipment and emergency procedures.****Personal precautions.**

Avoid contact with skin, eyes and clothing. Ensure adequate ventilation, especially in confined areas. All equipment used when handling the product must be grounded. Eliminate all ignition sources (no smoking, flares, sparks or flames in immediate area). Wear protective gloves/clothing and eye/face protection. Stop all work that requires a naked flame, stop all vehicles, stop all machines and equipment that may cause sparks or flames. Do not breathe vapors or spray mist. Avoid exceeding of the given occupational exposure limits (see section 8).

Thoroughly decontaminate all protective equipment after use. Personal protection needs must be evaluated based on information provided on this sheet and the special circumstances created by the spill including; the material spilled, the quantity of the spill, the area in which the spill occurred, and the training and the expertise of employees in the area responding to the spill.

## **7. Handling and Storage**

### **Conditions for safe storage, including any incompatibilities.**

#### **Advice on safe handling.**

#### **Engineering Measures.**

##### **Eye/Face Protection.**
